School-Based Parent Involvement Policy

The Roselle Public School District unequivocally believes that a partnership amongst home and school is essential for student success.

Therefore, **the Kindergarten Success Academy** agrees to adopt and implement the following statutory requirements of the Federal Every Student Succeeds Act (ESSA) as its Title I School-Based Parent Involvement Policy:

I. ELEMENTARY SCHOOL EXPECTATIONS
